

Battle of the Babes – World Model Search



TERMS AND CONDITIONS

The following terms and conditions relate to entry into the competition known as Battle of the Babes – World Model Search

Entry is via registration at the Battle of the Babes website (<http://www.worldbattleofthebabes.com>)

The deadline for entry is the day prior to the starting dates of the heats for each region. (Please note: enter as soon as you can, the promoter cannot guarantee placement of late entries).

1. Only one entry per model. The promoter reserves the right to accept or reject entries at their absolute discretion.
2. All models must be female and 18 years of age or over. Please be aware that venues may require photo ID due to their licensing obligations (For models as well as fans / attendees).
3. Unless otherwise informed (some events may have make-up / hair artists supplied) models are to do their own make-up and hair styling.
4. Models must be available to appear at designated dates in the region of entry, anytime between the start dates and final dates of that region. The model must also be available to compete at the World Final in Hong Kong. Dates for each region and finals will be announced via the event website.
5. Models are to be available for promotional commitments as required, to be arranged from time to time.
6. The Promoter accepts no responsibility for incomplete entries, or those lost or delayed for any technical or other reason. Models will be informed by the Promoter 1-4weeks after entering of the acceptance or ineligibility of their entry, including appearance date, venue and further details as they become available.
7. The model agrees to allow the promoter to film and/or photograph the appearance(s) of the model. The promoter and/or photographers own the copyright in this footage / images.
8. The model hereby warrants that she is either the owner or controller of the copyright or has permission by the copyright owner of the images of the model provided in the registration and uploaded onto the website, and are free to enter into this agreement and by doing so grant to the Promoter a non-exclusive license allowing the images and any other content provided to be reproduced in all media for promotion or any other use without recourse to any payment or fee.
9. At all times during the competition, & subsequent promotion of the competition, the model agrees to act in a professional manner that supports and reaffirms the reputation of the Promoter and sponsoring companies. To this end the Promoter reserve the right to cancel any model where this reputation is under threat by actions from any model or their associate(s).
10. The winning model of each country will win flights and accommodation to the World Final in Hong Kong provided for by the promoter, in addition, the overall winner will win flights to Paris including accommodation. The model must have her own passport (After winning the local events of her country) & is responsible to organise any possible necessary visa processing to enter Hong Kong to attend the World Final & France.
11. In countries with nationwide programs of Battle of the Babes events; The National finalist models shall be responsible for their own travel to the National final and accommodation in the hosting city, and any other expenses associated with competing in the National Final.
12. Prizes are non-transferable and there is no cash alternative for any goods or prizes. In the event that, having been notified of a placement in a semi-final, regional final, national final or world final, the model is unable to confirm their attendance, by the date required by the Promoter, they are therefore deemed to have forfeited, and the Promoter may subsequently nominate another model.
13. The winning model(s) will be announced on the night of each show, decisions are final. Winning model(s) will receive further details following their win, regarding placement in any semi-final, regional, national or the world final.
14. The Promoter reserves the right to terminate or temporarily suspend this competition in the event of technical or other difficulties that might compromise its integrity.
15. The terms and conditions are governed by NZ law and are subject to the exclusive jurisdiction of the NZ courts.
16. By entering the event, all participants are deemed to have accepted these terms and conditions.
